On Friday, December 14, 2012 at approximately 0941 hrs., Troop-A dispatch broadcast a report of an active shooter at the Sandy Hook Elementary School, 12 Dickinson Drive in the Town of Newtown. I responded from my patrol, in the Town of Roxbury and arrived at approximately 1000 hrs. I informed Troop-A of my arrival via police radio. I was able to park my marked cruiser in the parking area within 200-300 ft. in the east side parking area. It was at that time, I was notified by Sgt. Michael O'Donnell #272 to assist Detective Rachael Van Ness #1431 in evacuation of persons exiting the main entrance area to safe refuge.

Several evacuees were led to my position and with the assistance of an unidentified male civilian, led the evacuees away, maintained a perimeter to protect family members arriving, from breaching the perimeter and maintained scene security throughout. After an unknown amount of time elapsed, I moved my position to an area where Sgt. Deltorto #101 had begun to assist school staff in an orderly evacuation taking place on the south side of the school and down the sidewalk toward the Fire Department. Once the evacuation was completed, I moved my position to the area of the Fire Department where the perimeter had been extended. I performed that task until relieved and assigned Victim Family of 01 02 03 12
