ACTION TAKEN:

On 12/14/12 I was working an overtime job in Waterbury on Route 8 North near the I-84 interchange. I heard Troop A dispatch report an active shooter situation at Sandy Hook Elementary School. I left the pattern on Route 8 once it was finished being set up and responded to the scene. While I was en route, transmissions came over the air that there were possibly two shooters and ambulances were being requested.

When I arrived in the area I pulled up the driveway past the Sandy Hook Firehouse and positioned my cruiser at the top of the driveway just prior to the main parking lot in front of the school. There were several police and civilian vehicles parked all along the entrance road and inside the main parking lot. There were kids running down the driveway and emergency personnel everywhere. I observed many civilians running up the driveway toward the school. I exited my vehicle and grabbed my assigned AR-15 rifle from the trunk of my cruiser, loaded it, and continued towards the school.

As I approached the school from the left side of the driveway I observed Detective Van Ness #1431 leading a line of children down the sidewalk towards the firehouse. I observed Tpr Gregg #701 at the front left corner of the school and he appeared to be holding a perimeter with his long gun. I was asked to assist with keeping the parents and other on-lookers back from the scene and to help guide the children down the sidewalk. I believe Detective Van Ness asked me to do this. There were several large groups of children and some adults exiting the building. I continued to cover them and point them towards the Firehouse. EMS personnel asked me for cover at one point to help them enter the front left side entrance. Tpr Taylor #446 came to assist with guiding the children out and keeping the parents back. Tpr Gregg was not at the corner of the school at this time, so after I led the EMS personnel in, I remained there. I observed uniformed Troopers and Officers searching the wood line. Shortly thereafter Tpr Gregg returned to this area and we were both asked by Tfc Bell #354 to enter the school at the front left side door. He advised that he needed us to meet up with two Newtown Officers for a dog track. We entered the school and went into the front hallway where I observed the bodies of two

women lying lifeless in the hallway to my left. There were several shell casings in the hallway and blood spatter. I continued walking down the hallway to a group of uniformed Officers and Troopers in the main entrance to include Lt Delvecchia #034. We walked into the main entrance area. I observed a large hole in the glass to the left of the doors as I looked out of the school. In the entranceway there were Newtown Officers, one whom I recognized as Officer Chapman. We were apparently no longer needed for the dog track and I exited the building through the main entrance.

I went down to the Firehouse where I met Sgt Aiken #189. He advised me that the parents and surviving children and school personnel were inside the Firehouse and were attempting to make contact with their families. I entered the main garage area of the Firehouse and began speaking with children and adults who were frantically looking for people. I saw that groups were forming, as teachers were getting the students from their classes together and checking them off as their parents met up with them. A second room inside the Firehouse was forming as time went on. The families that could not locate their children or family members were being moved into that second room. I then began taking statements from the teachers and school personnel who were present as I saw other Troopers doing so. The details of my duties from here on are in separate supplemental reports.
