Officer McCluskey responded to the Sandy Hook School mass shooting.

ACTION
TAKEN:

On 02/06/13 at approximately 1020 hours, I met with Officer John McCluskey within the Newtown Police Department. Prior to this meeting, Officer McCluskey provided his own typed written statement utilizing a State Police form. After reviewing the statement, Officer McCluskey and I signed the statement. In summary, Officer McCluskey's statement provided the following information:

On 12/14/12, he was working a side job for CL&P when he heard a dispatch for gun shots at Sandy Hook School. Upon arrival at the school, Officer McCluskey assisted Officer McGowan and then was directed to Yogananda Street. Officer McCluskey stated that he never entered the Sandy Hook School as there were numerous emergency responders at the scene.

Upon arrival at Yogananda, Officer McCluskey and others evacuated adjacent residences and secured the area while waiting for SRT (Special Reaction Team). At no point did Officer McCluskey enter or approach Yogananda. Officer McCluskey added that the Yogananda residence was quiet with no activity. At some point, he was told by State Police that there was a deceased body inside the residence. Officer McCluskey secured the Yogananda residence scene until after midnight when he was relieved (See attached written statement for details).

On May 24th, 2013, I obtained a clarifying written statement from Officer McCluskey. In summary, Officer McCluskey stated that on 12/14/13 (meaning 12/14/12) he was on a side job with CL&P on Queen St. and believes his assigned shift was from 0800 to 1600. Officer McCluskey heard units being dispatched to Sandy Hook School for a report of shots fired. Officer McCluskey arrived at the school at an unknown time and met with Officer McGowan. Officer McCluskey never went in to the school. Officer McCluskey then responded to the residence on Yogananda St. and assisted Officer McGowan in evacuating adjacent residences and securing the premises while awaiting the State Police (See attached written statement for details.)
