

Detective Joudy responded to the Sandy Hook School mass shooting.

ACTION TAKEN:

On 02/06/13, at approximately 1015 hours, I met with Detective Joudy within the Newtown Police Department. Prior to this meeting, Detective Joudy provided his own typed written statement utilizing a State Police form. After reviewing the statement, Detective Joudy and I signed the statement. In summary, Detective Joudy's statement provided the following information:

On 12/14/12, at approximately 0935 hours, Det. Joudy and Det. McAnaspie heard a radio transmission reporting gun shots at Sandy Hook School. They both responded from Danbury Superior Court, lights and sirens. At approximately 0950 hours, they arrived at the school. There they met up with Captain Rios who instructed them to secure the side and rear of the school. Det. Joudy initially went to the rear of the school and then to the front where he learned that there were numerous fatalities inside. Connecticut State Police Major Crime Unit arrived where Det. Joudy, Det. McAnaspie and Det. Frank were assigned to work with the unit for the next six days (See attached written statement for details).

On May 24th, 2013, from approximately 1030 hours to 1045 hours, I met with, Det. Joseph Joudy, within the Newtown Police Department for the purpose of clarifying his aforementioned statement. In summary, Joudy stated in his previous statement that he arrived at Sandy Hook School on 12/14/13 and the date should have been 12/14/12. Det. Joudy also stated that he worked with the CSP Major Crime Squad for the next six days and now believes he left the school on 12/18/12. Furthermore, while securing the rear of the school he was alone and he never saw any children or teachers leaving through the side doors. He stated that his position was near the fence behind the portable classroom (See attached statement for details.)
