On 12/14/12 I, Tfc. D'Uva #410 responded to 12 Dickinson Dr. Newtown CT, the Sandy Hook Elementary School for a reported active shooter situation. I heard on the police radio that a possible shooter was down and that they are actively searching for a second shooter.

Upon my arrival at approximately to my knowledge 1000 hours, I parked my cruiser on the access road leading to the gate of the school's parking lot due to the vehicles on scene. I immediately ran towards the school and approached to the front entrance of the school. I observed a window to the right of the main door to be smashed with glass particles throughout the entry. I entered the lobby and observed an array of what I recognized as spent rifle casings scattered about the floor. At this time I observed two lifeless adult females laying on the floor with a pool of blood around them. I observed officers walking down the north hallway so I turned and headed down the north hallway since it was reported that they were searching for a second shooter. The first room I went to was I believe room #12 which was empty and cleared. I then proceeded to the next room which I believe to be room #10. I entered the room and observed a young white adult male laying in a pool of blood. I observed him to be wearing BDU style pants and a vest. I also saw a black pistol laying on the floor near him and another in a holster on his side. The male was wearing what I believe to be ear plugs in his ears. I then looked through the room and I saw an assault AR-15 style rifle laying on the floor and an adult female laying face down with a child.

I then walked out into the hallway and was told by an officer something to the effect of, there wasn't anything else to do there its been cleared and that we need to get people out. I then went to the lobby and headed down the west hallway. Children were being evacuated from classrooms. I began escorting kids out and was told by Master Sergeant Davis that the students need to be escorted out of the building and to help them to the fire house located at the end of the access road. I observed the smaller children walking out and escorted by a teacher and led down the road. I observed the older children to be running and scattering as they fled. I escorted a group down to the fire station and as I arrived I observed an influx of students, parents and teachers. I began clearing the fire station to accommodate the increasing crowd. The fire station was being prepped as a
