On 12/14/2012 I was assigned to respond to the Sandy Hook School in Newtown, CT in response to an active shooter incident which was in progress. I responded along with Chief Fuchs and Officer Heibeck. Upon our arrival at approximately 0945 we parked at the Sandy Hook Fire Department, which is located near the Sandy Hook School gathered our equipment and proceeded to the Elementary School.

Officer Heibeck and I then recognized Officer McGowan of the Newtown Police searching cars in the parking lot of the school. I then asked him if he needed our assistance. He advised he did and stated that there was a shooter in the school who had taken his own life and they were not sure if there was another. At this time Officer Heibeck and I then searched the vehicles in the parking lot along with Officer McGowan. We then noticed an officer questioning a male individual wearing a brown jacket who had no reason to be on scene. We then assisted the state police in searching his vehicle and taking him into custody.

Shortly after we were asked by LT Vanghele of the Newtown Police Department to go into the Sandy Hook Fire Department to assist with the families. [REDACTED]
