ACTION TAKEN: On 02/25/13 at approximately 0914 hours, I met with Captain Jose (Joe) Rios, of Newtown Police Department, with regards to the ongoing investigation. The purpose of this interview was to obtain a statement regarding Rios' response to and duties performed in relation to the SHES shooting on 12/14/12. During the interview, Rios stated, in part, the following:

That on 12/14/12, he responded from the police department on Main Street after hearing the news of the shooter from someone in the building. He arrived with Chief Kehoe in Kehoe's vehicle and responded to the left side (when looking at the front of the school) of the building where he heard that Officer McGowan and Sgt. Kullgren were out with a male "suspect", later identified as a parent, 01 02 03 12, 04. Rios took custody of 01 02 03 12, 04 and turned him over to an Oxford Constable Ramirez. Rios then stated he went back to the school and performed his duties and was later assigned to the EOC, located at the former Fairfield Hills Hospital in Newtown.

See attached written statement prepared and notarized by me, and sworn to and signed by Rios.

CASE STATUS: This case will remain open pending further investigation.
