**ACTION TAKEN:**

On 04/19/13 at approximately 0850 hours, I met with Newtown Officer William Chapman at the Troop A Southbury barracks with regards to clarifying a misunderstanding with the chronology of events regarding his entry into classrooms 10 and 8 during the Sandy Hook School shooting. The purpose of this statement was to amend a portion of his initial statement as a responder. Officer Chapman stated that he completed this statement

while working his assigned midnight shift with Newtown PD from 0400 to 0500 hours and copied it to his flash drive. Officer Chapman stated, in part, the following: He believes that he evaluated and removed the child, later identified to him as **01 02 03 12**, upon his initial entry into classroom 10. Officer Chapman stated that he then believes, that upon returning to the school, he then entered classroom 8.

I then had Officer Chapman clarify some information regarding his direction of entry into the room and the location of the victim child in the room. This information was placed into an additional statement. Officer Chapman stated, in part, the following: When he entered room 10, the second classroom on the left, he walked in straight, passed the shooter, and around (pointing to the right) what he thought to be a table to check for victims. Officer Chapman stated that he remembered that the teacher nearest to the window was that last person he checked for injuries before he turned and saw a small female child lying on the floor near the legs of a circular table. Officer Chapman stated that he removed the child and carried her to an ambulance. See attached written statements.

The first statement (2 pages) was prepared by Officer Chapman, notarized by me, witnessed by Det Van Ness, and sworn to and signed by Officer Chapman.

The second statement was prepared and notarized by me, witnessed by Det Van Ness, and sworn to and signed by Officer Chapman.

CASE STATUS: This case will remain active pending further investigation.
