ACTION TAKEN:

On 12/14/12 at approximately 0930 hours, I was working an overtime assignment with Lewis Tree Services on Christian Street in Oxford. At approximately 0937 hours, Troop A dispatcher Brennan dispatched cars to Sandy Hook Elementary School in Newtown, CT. 01 02 03 12

. At approximately 0949

hours, I arrived at Sandy Hook Elementary School and parked my assigned Oxford Police vehicle on the left side of the parking lot. I put on my body armor over my uniform coat and headed toward the school. I was approached by Captain Rios from Newtown Police Department. Rios directed me toward a white male who was handcuffed. Rios directed me to uncuff the male party since he was a parent and not a suspect. Rios advised me to tell the parent to stay back away from the school. The parent indicated that he has a child in the school and asked what was going on inside. I advised the parent that **01 02 03 12** and that I was heading into the school to find out what was happening. I advised the parent to head away from the school, toward the back of the parking lot and I went to the front doors of the school.

A Newtown Officer had propped open the door as I was arriving. As I entered the lobby of the school, I observed two deceased females near the entrance to the north hallway. As I passed the two deceased females, I saw Sgt. Cario in a classroom on the right side of the hallway. Sgt. Cario was administering first aid to an injured female. Sgt. Cario directed me to cover the north hallway, as there may be a second shooter. I covered the hallway for a short time and then I proceeded into the room across the hall. Upon entering the room, I observed the deceased shooter near the doorway. I continued to the left and observed several deceased children and teachers. I turned around and exited the room, back into the hallway.

Upon returning to the hallway, I joined up with TFC Cipriano, Officer Chapman and MSgt. Gelven to form a search team. We continued to search classrooms in the north hallway of the school. As we made the turn down the east hallway, we went into one classroom on the left side of the hall and there was an injured teacher and many children. We escorted the injured teacher and children to the doorway on the east side of the school and

turned them over to another officer, who took them across the parking lot. We continued to clear classrooms in the east hallway, to the south side of the school. As we approached the back of the school, I observed Captain Rios breaking a small glass window in the door to gain access to the school. We made the turn into the south wing of the school and continued to clear all the classrooms down to the library. A few of the classrooms had children present and we directed them to the exit door in the southeast corner of the building, where Captain Rios was entering. We continued to clear the hallway on the west side of the school and eventually made it back to the front lobby.

01 02 03 12
I returned to the firehouse and assisted in directing traffic near the firehouse on Dickinson Dr.

I remained in the area of the firehouse until approximately 1700 hours. I then returned to Troop A with TFC Duva.

CASE STATUS:

This case remains ACTIVE pending further investigation.
