**INTERVIEW REPORT-Liam Seabrook**

SUBJECT: Liam Seabrook (d.o.b. **03**)  
3 Main Street  
Newtown, CT.

DATE AND TIME: This interview was conducted on 08/08/13 from approximately 1645 hours to 1705 hours.

LOCATION: This interview was conducted at Troop A, located at 90 Lakeside Rd. in Southbury, CT.

**ACTION TAKEN:**

On 08/08/13 at approximately 1645 hours, Newtown Officer Seabrook came to Troop A in Southbury to provide a supplemental statement to the statement that he provided on 12/15/12 regarding his response to the shooting at Sandy Hook Elementary School. The following is the statement provided by Seabrook on 08/08/13:

"This statement is a supplemental to the statement given on 12/15/2012 to investigators and is to the best of my recollection. On 12/14/2012 I was inside one of the classrooms of the Sandy Hook Elementary School where Adam Lanza's body was found. There were several other officers inside the classroom including Newtown Police Officers and Connecticut State Police (CSP) Troopers. At some point during this time, CSP Sergeant

O'Donnell and I were running serial numbers from the firearms that were found in the classroom. Pictures of the scene and of the locations of each firearm were taken prior to any manipulation. One of the firearms found in the classroom was an AR-15 style rifle. To the best of my memory, the rifle was found with the ejection port facing up, and the side with the serial number facing down. After pictures of the rifle were taken, I turned the rifle over to read the serial number. The rifle was not moved from its location, only manipulated to record the serial number. I do not recall observing any weapon jam of any sort with the Ar-15 stlye rifle. The only weapon jam I recall observing was the Glock pistol found near Lanza's body."

This interview was concluded at approximately 1705 hours.

CASE STATUS:

This case remains ACTIVE pending further investigation.
