ACTION TAKEN: On 08/20/13, at approximately 1500 hours, Newtown Officer William Chapman met with me at the major crime office at Troop A to provide a revised statement regarding his account of the events that occurred on 12-14-12 at SHES. Chapman had previously provided revised portions of his statement. Chapman stated that the purpose of providing this revised statement was to provide a clearer and more complete account of his involvement in the incident at SHES to include a more accurate chronology of events, information given in supplemental reports, and details of

secondary tasks that were completed by him (SEE ATTACHED STATEMENT).

After reviewing the final statement and comparing it to his previous statements, I found that the final statement incorporates Chapman's revisions that upon entering room ten, he stayed in room ten, checking pulses and removing a victim to a waiting ambulance. Upon returning to the school Chapman then went into classroom eight. In his final statement, Chapman provided more details about his movements in clearing the classrooms of the school, standing guard while the Paramedics enter rooms eight and ten, assisting CSP canine officers with perimeter searches, ESU searching the building, and the different assignments that he carried out on the day of the shooting.

The statement was prepared by Chapman on 08/15/13 between the hours of 1700 and 1722, and reviewed by me on 08/20/13 between the hours of 1500 and 1525. The statement was then sworn to and signed by Chapman, notarized by me, and witnessed by Det Mudry.

CASE STATUS: This case will remain open pending further investigation.
