INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Saturday, December 15th, 2012 between 1621 and 1644 hours I, Det. Roy # 518, interviewed Peter Barresi. Mr. Barresi was a First Responder/Firefighter with the Sandy Hook Fire Co. that set up a triage station in the parking lot adjacent the school. Mr. Barresi provided the attached written statement. In summary, the statement reads as follows:

I've lived at the above address for the past 4 yrs. and serve as a volunteer firefighter at Sandy Hook Fire House for the past 12 months. On 12/14/12 I was at the firehouse when I overheard the chief end a conversation with something about a possible shooting at the elementary school. At some point we were dispatched up to the school and Bill Halsted-Chief, John Jeitoma-Captain, Ryan Clark-Lieutenant, Karen Halsted-EMS Captain, and I responded on Rescue 444. On the way there were several vehicles that had to be moved but we managed to set up a triage post in the first parking lot between the stop signs. At some point someone came to get us and we treated a female GSW victim near one of the parked cars. We continued to prepare for casualties. But none ever came out. We were not allowed to enter the building and slowly we were moved back to a second triage center. END OF STATEMENT.
