INTERVIEW REPORT

Date and Time of Investigation:

Friday, December 14th, 2012 at approximately 0930 hours.

Summary of Incident:

On the above mentioned date and time members of the Western District Major Crime Squad responded to the scene of an active shooter within the Sandy Hook Elementary School located at 12 Dickerson Drive Newtown, CT.

As a standard procedural function in this type of investigation several witnesses were interviewed throughout the investigation.

Action Taken:

On Saturday, December 15th, 2012 between approximately 1600 and 1727 hours I, Det. Roy # 518, interviewed Ryan Clark. Mr. Clark was a First Responder/Firefighter with the Sandy Hook Fire Co. that set up a triage station in the parking lot adjacent the school. Mr. Clark provided the attached written statement. In summary, the statement reads as follows:



My name is Ryan Clark and I am a 7 year member of the Sandy Hook Volunteer Fire and Rescue Inc. I hold the position of Lieutenant. On Friday December 14th, 2012 while at work at 51 Church Hill Road, my pager alerted me of a medical emergency at the Sandy Hook School. I drove my personal vehicle to the firehouse, where I boarded the Rescue truck along with Chief Bill Halsted, EMS Captain Kerin Halsted, Captain Joe Jeltema and Firefighter Pete Berressi. We responded up Dickerson Drive to the stop sign in front of the school. I exited the vehicle and proceeded to remove any medical equipment we might need into an area that would be called a triage station. EMS Captain Halsted Firefighter Berressi and myself were notified of a potential patient located at the corner of the parking lot furthest from the school. We found and rendered aid to the patient with a laceration to the foot. After wrapping the wound we transferred care to a female member of Newtown EMS. We then returned to the triage station area to continue preparing for the possibility of more patients. I worked to keep firefighters aware of available resources by contacting officer in the staging area. I never entered the building at any time, nor to the best of my knowledge did any other members of my crew. END OF STATEMENT.
