Interview of Bill Halstead, First Responder, Chief of Sandy Hook Volunteer Fire Company

ACTION TAKEN: On Saturday December 15, 2012 at approximately 1700 hours, Detective Andre Roy and I met with Chief Bill Halstead at the Sandy Hook Fire House located at 18-20 Riverside Road in Sandy Hook. The purpose of this meeting was to obtain a written statement from Chief Halstead regarding his actions as a first responder during the Sandy Hook shooting incident. Det. Roy and I were given the use of the Chief's office for the purpose of this interview.

In a verbal and later in a written statement, Bill Halstead states, "On Friday Dec 14, 2012 I was doing paperwork at the fire station at 18-20 Riverside Rd. Around 0935 I heard a siren coming up Riverside Rd shortly after that the ambulance Corp was toned out to standby on 92 Church Hill. On arrival at 92 Church Hill Rd the ambulance was told to proceed to S.H Fire Station and stage in rear parking lot. At this time I proceed to the parking lot where a CSP car approached the ambulance with a female pt (name unknown). At that time I was requested to assist the ambulance crew with patient removal. I went to the CSP vehicle and removed the victim and placed her on a stretcher. Pt appeared to have gun shots to right hand and lower leg. At this time we went toned out to assist at the scene, Myself, Capt John Jeltema, Lt. Ryan Clark, EMS Capt Karin Halstead and F.F. Peter Barresi. When we arrived on scene I told command and had my crew setup for triage. I was the I.C. of the incident for Fire and EMS. We stayed on scene to approximately 14:45 hrs." Chief Halstead's written statement is attached to this report.
