Queen Street near its intersection with Elizabeth Street, Newtown, CT. During this time I heard Newtown Emergency Communications Center (NECC) dispatch a call for service at Sandy Hook Elementary School reporting a shooting inside the school. While working the private duty assignment I continued to monitor the radio transmission of the events taking place at Sandy Hook Elementary School. At approximately 10:10 hours CL&P appeared to have reached a point where their work on the utility pole could be safely stopped. Ofc. McCluskey then informed CL&P that we had to leave the private duty detail and go elsewhere in town for a serious call. I then drove Ofc. McCluskey to Sandy Hook Elementary School so we could give our assistance.

We arrived at Sandy Hook Elementary at approximately 10:30 hours and we began to walk through the parking lot towards the front entrance of the school. I then spoke to Newtown Police Chief Kehoe who told me to stand in the front entrance of the building and scribe the names of individuals who were on scene. I then located a pen and paper and went to the front entrance of the school and began to scribe names. I remained at this post until approximately 15:00 hours until I was relieved by a member of the Connecticut State Police. I turned over the pen and paper including my list of names to the Trooper relieving me.

During my time at the school I remained in and around the immediate front entrance of the school. I stepped briefly into the front foyer area, but did not walk down the hallway or into any classrooms."

The typed statement was signed by Lorancaitis, witnessed by Detective Lukienchuk #573 and I notarized the statement.
