

At approximately 0946 hours this Sergeant overheard a radio transmission by Officer T. Begley #614 reporting an active shooting at the Sandy Hook Elementary School located in the town of Newtown. I immediately responded in emergency mode to the scene.

I arrived at the scene at approximately 1023 hours, I armed myself with my department issued rifle and appropriate tactical vest. At that point I walked toward the front entrance of the Sandy Hook Elementary School. At that point I was joined by Officer Tate Begley. We were met by a Troop A Master Sergeant who stated he had multiple victims deceased.

Moments later DEEP Captain Camejo #689 ordered Officer Begley and me to join up with Officer's Stone and Bruno to cover the perimeter of the north side of the school. The Master Sergeant did at that point notify us that he believed that (1) suspect was also deceased. It was believed that multiple gunmen could still be present in and around the location.

At that point the four DEEP officers tactically relocated to the north side of the perimeter. Officers were staged approximately 100 yards apart. We covered the entire north side of the building and from the high ground we also had a clear visual of the entire rooftop. At approximately 1100 hours I went to make personal contact with all the officers on the north perimeter. I was unable to find Officer Matt Stone #615. Using a department issued cell phone I contacted him. Officer Stone advised me that he was pulled from the perimeter and was now inside the Sandy Hook Elementary School.

At approximately 1105 hours I walked to the entrance to the school. Upon arrival I spoke with an unidentified Newtown Police Officer. The Newtown Officer then asked if he could help me. I explained that I needed to make contact with Officer Stone. The Newtown officer then asked for my name and badge number. The Newtown officer then wrote my name down on the entry roster. The Newtown officer then allowed me to enter through the front doors.

As I entered I could see that the window to the right of the entrance was broken with glass strewn about the ground. After passing through the entrance into the foyer I could see two adults lying against a wall with injuries consistent with what appeared to be multiple gunshot wounds. To the right side of the foyer were a Connecticut State Police Captain and I believe a Lieutenant? I spoke briefly to the Captain of my purpose inside the school. The Captain then stated "I think he is down the right side of the corridor. I then walked down the hallway toward the eastern portion of the building. I met with another unidentified Newtown officer and briefly spoke to him. I then continued south walking toward a Newtown Police Sergeant. After a brief conversation I walked west toward a Connecticut State Police Master Sergeant. Yet again we spoke briefly. At that point I could clearly

see up the north corridor toward the foyer. Unable to find Officer Stone the Master Sergeant stated "you can walk toward the entrance, but I wouldn't if I were you. I don't think you want to see what's in the room on the left". I agreed and proceeded back the way I entered. It should be noted that I was wearing gloves and did not touch any doors or items. I exited the building through the front entrance.

Upon exiting the building I met with Captain Camejo. I explained that I was still looking for Officer Stone. At approximately 1120 hours I found Officer Stone positioned approximately 3 feet inside a utility closet with the door opened to the outside. At that point I told Officer Stone that he was relieved from his position. I directed Officer Stone to drop back to the wood line and take up a perimeter position.

At approximately 1445 hours all DEEP officers were relieved of our positions. The ten DEEP officers then met in the south parking area and departed the scene approximately 10 minutes later."

The typed statement was signed by Sgt Dwyer, witnessed by Detective Lukienchuk #573 and I notarized the statement.
