"On 12/14/12 I CT Environmental Conservation Police Officer Keith Williams # 638 was contacted by EnCon Police Dispatch regarding an active shooting at the Sandy Hook Elementary School in Sandy Hook, Newtown. I was just leaving GA # 5 with Officer Paul Hilli # 676 and proceeded down RT 34 followed by Officer Hilli. Upon arrival at the school parking lot at approximately 0930 hours I and Officer Hilli grabbed our patrol rifles (AR-15) and proceeded to the school entrance. I observed teachers, staff leading children from the school building. I asked an unidentified CT State Trooper who was directing emergency personnel where he needed my assistance. I was directed by said CT State Trooper towards the back of the building (south facing) where the playground area is located. I met Officer Bennecci (K-9) at the side entrance door and stepped into the building approximately 10 feet where he directed me to lead a group of teachers and children out to safety. I did so and led approximately 40-50 staff and children out of the school, through the parking area and out towards the Fire Department. I was holding onto a young girl's hand who was screaming "help me, help me"! I returned to the school and took a second group of teachers and children on the same route. I got the second group to safety and returned to the corner of the building where I met the same unidentified CT State Trooper who directed me to relieve another CT State Trooper who was standing guard behind a tree next to the playground covering the building. I relieved that Officer and took a position behind said tree.

Within minutes I was directed by CT State Trooper Joe Bukowski # 763 to accompany him in securing the outer perimeter of the school and the wooded area behind the school and Crestwood Rd. I and Trooper Bukowski checked the perimeter and focused our attention to Crestwood Rd where we came in contact with [redacted] 04 who was walking from a residence at # [redacted] 04 was appropriately identified by his CT driver's license and confirmed he lived at # [redacted] 04 stated he needed to get his wife to [redacted] 04 for the school district. We cleared [redacted] 04 and continued sweeping the street. I and CT State Trooper Bukowski checked the last property # 14 Crestwood Rd and surrounding wooded area finding no conclusive evidence of any suspect involved.

We then proceeded back up the street and observed a small sedan bearing CT Registration number [redacted] 01 02 of which we conducted a full felony stop. The operator was identified by his CT driver's license # [redacted] 01 02, 04, a parent of two children attending the school. The operator was cleared and directed to exit the area and proceed to the fire house. Within ten minutes we observed a second vehicle approaching us with two passengers bearing CT registration # [redacted] 01 02 of which we also conducted a felony stop on. The operator was identified by his CT driver's license [redacted] 01 02, 04 and the passenger was identified by her driver's license [redacted] 01 02, 04. Again both were parents of children at the school, cleared and directed to the fire house. CT State Trooper Bukowski and I then cleared several news media crews out of the area due to safety concerns.

Trooper Bukowski and I were then approached by CT K-9 State Trooper Bennecci and searched the Crestwood area with his K-9 again with negative results. Trooper Bukowski and I then took a position at the southwest corner of the school grounds where we observed a gate with a chain that was cut and what looked to be a black glove pouch on the ground. There were 2 pieces of cut chain on the ground next to the glove pouch. While standing guard at the rear gate we observed two more unmarked vehicles approaching us at a high rate of speed. We conducted felony stops
