

Monroe K-9 officer, Loomis provided a typed statement.

"My name is Officer Jeffrey Loomis, badge # 27, who is employed by the Monroe Police Department, currently assigned to the K-9 Unit on the midnight shift. I have been employed by the Town of Monroe since May 26th, 2006, and have been assigned to the K-9 Unit since May 2011.

On December 14, 2012, approximately 10:15 hours, I received a call from Dispatcher Babson, of the Monroe Police Department, requesting K-9 Gunner and I to respond to assist the Newtown Police Department at the scene of a shooting at Sandy Hook Elementary School, Sandy Hook, Connecticut.

At approximately 10:35 hours, I arrived at scene and spoke with Monroe K-9 Officer Bradshaw, badge # 46, who was already on scene. Ofc. Bradshaw informed me the command staff wanted K-9 Gunner and I to assist with the perimeter by taking post at the southeast rear corner of the school.

K-9 Gunner was brought out of my patrol vehicle and placed in his K-9 Storm vest. I also grabbed my AR-15 rifle and headed to the school. As I was walking up to the school, I was met by Ofc. Bradshaw and CSP Trooper Vayan Jr, badge # 1182. I gave Trooper Vayan my long rifle since he was taking up a position with Ofc. Bradshaw.

I arrived at the post and relieved a CSP K-9 Trooper, who was already holding the perimeter. The CSP K-9 Trooper went to assist other K-9 teams that were searching the area. While the CSP K-9 Trooper was searching the perimeter, he discovered a small pouch near the rear gate of the school. I did not see the pouch, but it was described to me as a small pouch like the one a police officer would have on his duty belt to keep medical gloves in.

After about two hours and the school was cleared, I was relieved by another Trooper. K-9 Gunner was brought back to my patrol vehicle and placed inside. I then proceeded to go back to the front of the school to see if any other assistance was needed. While in front of the school, Ofc. Bradshaw and I were looking where the bullets had exited the windows. We then looked around the parking lot to see if there were any markings or casings. Behind a sedan in the second row (not positive), I located a shotgun casing, which was not spent. I notified an investigator on the discovery.

A few hours later, I saw Trooper Vayan and retrieved my rifle. At approximately 15:30 hours, one of the member of the Newtown Police Department
