ACTION TAKEN: Interview of [REDACTED] 03, 04 on 12/15/12 at 1207 hours

On the above mentioned date and time this Detective and Det. Kimball interviewed [REDACTED] 04 at his apartment located at [REDACTED] 03.

At approximately 1207 hours on 12/15/12 [REDACTED] 04 began his statement. [REDACTED] 04 completed his written statement at 1235 hours on 12/15/12. [REDACTED] 04 swore to and signed his statement. (See attached written statement) Among other things, [REDACTED] 04 provided the following information in his statement:

[REDACTED] 04 stated that on 12/14/12 at approximately 9:40AM, he was returning from the Mobil gas station in Sandy Hook, Connecticut. As [REDACTED] 04 was driving by the Sandy Hook Fire department, he observed five children running down the middle of the road. [REDACTED] 04 stopped along with a woman in a minivan and calmed the children down. [REDACTED] 04 stated the children were scared and said something to the effect of "people were dying at the school and they didn't want to go back to the school". [REDACTED] 04 had the children give him their home phone numbers and he began calling the numbers to reach their parents. [REDACTED] 04 said he only was able to speak to one female parent, the other four calls went to voice mail and he left messages. [REDACTED] 04 showed this Detective the phone numbers on his cell phone that he called that day.

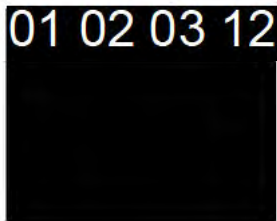

This Detective recognized the phone number of 01 02 03 12 as the home phone number for 01 02 03 12, 04

04 stated that he told all the parents to either go to Newtown Police Department to pick up their children or to call the school to see what happened. 04 stated that the woman in the minivan took all the children to the Newtown Police Department.

04 stated that he thought the woman in the minivan had a first name of 04 but he was not sure. 04 remained at the scene for another hour and a half and helped first responders in any way he could.

04 stated that his cell phone number has a 04 exchange because he purchased it when he lived in 04 prior to moving to Connecticut. 04 account of the phone call is consistent with the account provided by 01 02 03 12

The caller identification on 01 02 03 12 home phone listed 04 and appears to be an administrative mistake with the phone company's caller identification system.
