INTERVIEW REPORT

On 12-14-12 this Trooper and Detective Tanya Compagnone, #696, interviewed **04** in the home office of a residence located at **03**. It was reported that **04** contacted Newtown P.D. and stated that he had information about Nancy Lanza, a victim in the incident from earlier in the day and the mother of the shooter, Adam Lanza. It was reported on the lead sheet that **04** told a Newtown P.D. dispatcher that Nancy Lanza had told him she did not want to be in Connecticut the week of the shooting and was considering taking a trip to be sure she was out of town. This was thought to be some sort of foreshadowing of the incident. **04** stated he wanted to talk to investigators.

04 stated verbally and then later in a written statement that he dated Nancy Lanza in 2011 and after they broke up they remained friends and corresponded primarily via facebook and e-mails. He stated that he knew Lanza to own weapons and that she invited him to go shooting because it was a good stress release. He stated that he knew Lanza was from either New Hampshire or Vermont and was familiar and or comfortable with weapons from living there. **04** said he was not sure, but thought Lanza's brother was also a police officer. **04** stated that he did not know where Lanza stored her weapons. He said he was in the house on Yogananda only once and never met Adam Lanza.

04 stated that he knew Adam Lanza had aspergers and that he learned that from Nancy Lanza. He said that she retired from work because of the issues involved with the condition and to be with Adam.

04 was asked about the statement that Lanza stated she needed to be out of town and he stated that he knew she had a scheduled trip to

London and that there did not seem to be any urgency to leave town. **04** stated that he had a DUI incident and had his license suspended and used to ask Lanza to drive him around to run errands and she did. He stated they exchanged e-mails when he thought she was in London and that is when he found out she did not go to London. **04** said that Lanza told him she had to cancel the trip to London because of "a couple of last minute problems on the home front" but did not say what the problems were or who they involved. **04** said that he asked Lanza for a ride to a hair appoint on Friday, 12-14-12, and she stated that she had an appointment in Westport that day and couldn't help him. **04** stated he still had the e-mails and forwarded them to Det. Compagnone to be printed. See attached lead sheet copy, e-mails and written statement.

This case remains open.
