Following my telephone call with Dr. Lessell, I contacted the records department at the Lahey Clinic. I spoke with Sandra Fisher (supervisor of the medical records department) who confirmed there are records on file pertaining to the treatment of Adam Lanza, however a subpoena would be necessary for the release of those records.

This information was provided to Assistant United States Attorney Patel for the facilitation of a subpoena that would be executed by the Federal Bureau of Investigation.
