



You called me back at around 3:20pm on 12/16/12 asking for details about Adam Lanza.

My contact/personal information:



His Character:

- Would talk somewhat, but mostly quiet and kept to himself
- Dressed nicely, tucked in button-down shirt, plastic pocket-protector with pens
- I don't remember any incidents where he did very odd behavior
- however, he would always be fixing his hair, kept a supply of cleaning stuff in his black bag
- always kept his black bag with him, not sure what was in it aside from school stuff and cleaning stuff
- Never mentioned anything about guns, violence, other events or news about quns/violence
- Tech Club, and I remember our then Adviser and 04 to watch out for odd behavior, and that he was a very shy fellow. 04 wanted to make sure we understood we were trying to help him socialize more.
- I don't remember anything about him being bullied or teased. We in the Tech Club certainly did nothing of the sort, but I would not be surprised if he was bullied/teased at NHS, as bullying was a real problem in our schools.
- Mostly did not talk freely or much. I vaguely remember him stuttering and other nervous behavior while chatting.

Involvement in Tech Club:

- Our club really did try to befriend him. We had lots of odd members, but to us he wasn't that extraordinarily different at the time.
- Would laugh at the stuff we did/said, would occasionally make jokes with us in the Tech Club

- seemed to enjoy being with us
- Our club would broadcast games live on Channel 17 (we were called NTV). He always signed up to go to games and be camera man or help out at the game in someway. His attendance at the events isn't odd, there would always be a few members who would go to the majority of games (myself included, I went to well over 80% of the games or was part of them in some way over the 4 years I was a member).
- I remember him going to at least one LAN party at 04,0102 house. He seemed to enjoy it and was chatting with people there.
- He also hosted a LAN party at his own house, and lots of people went. I however was not able to attend (I can't remember why), I heard it was fun the day after.
- Would hang out in the Tech Room during his free periods/lunch/after school for our meetings. Would occasionally offer up bits of information during meetings or chat about whatever we were talking about.

After being with the Tech Club for a year, he didn't come back the year after (since he was homeschooled), and I have not talked to him since. None of his behavior (at the time when I was about 16 or 17) was at all indicative of someone who would do anything like this. In retrospect, the few interactions I had still would not point to any kind of violent behavior.

Do not share my personal information or contact information with anyone outside of law enforcement or individuals/organizations not directly involved with this case. Do not release my name, person, or image in relation to Adam Lanza to the public. I am only to be contacted if necessary and directly related to this investigation. I frequently check my e-mail and have my phone on me/near me most of the time.
