I was Adam Lanza's teacher in 04	grade at 04	for the last quarter of	f the school year.	

When I was watching the news about the Sandy Hook School incident and saw Ryan Lanza in handcuffs I knew that it would be Adam and not Ryan.

After my years of experience in teaching 04 grade boys I know how they are supposed to act. But I saw Adam as being not normal with very distinct anti-social issues. Adam was a very intelligent boy but he was also very quiet, barely spoke and never responded to his classmate's kindness of trying to help him fit in. I also remember Adam never wanting to participate in anything. I truly do not believe that Adam's parents were upfront with teachers about Adam's mental capacities.

I remember giving creative writing assignments to students instructing them to write a page or two on whatever they wanted to talk about. Adam would write ten pages, obsessing about battles, destruction and war. In my years of experience, I have known **04** grade boys to talk about things like this but Adam's level of violence was disturbing. I remember showing the writings to the Principal at the time. Adam's creative writing was so graphic that it could not be shared. I remember instructing Adam that he had to write something else to share for the class. Instead he wrote a poem, from what I recall was beautiful. Adam shared his poem in public with his father present who was in tears. I believe his father was in tears because he's never heard Adam cite anything that nice before and the surprising fact that he was able to stand up and deliver the poem in public. At
