In this time he was a generally quiet kid and I would say he seemed overly anxious partly because of his facial expression and that he always seemed to walk very upright. I don't recall him ever having a panic attack or violent outbreak, at least that I ever noticed. He did have a notable compulsion in that if you handed him something he would pull his sleeve over his hand before he took it and then wipe it off quickly before he actually touched it, but I don't know if there was an underlying phobia. Other than that, he was quiet but he was sociable so long as you made him feel like he was included in the conversation. I hope this helps your files.
