## ACTION TAKEN:

On January 9th, 2013, Lt. DelVecchia received a message from 04, 01 02 sic] who stated in summary that her daughter had seen Adam Lanza at Newtown High School the day of the shooting.

I left a voice message for 04, 01 02 and she returned my call at approximately 1440 hours. 04, 01 02 stated that she did not want her daughter to be named within this report and she provided the information to me. On the day of the shooting her daughter came home and told 04, 01 02 that classmates had told her that they saw Adam Lanza in the parking lot before the school shooting.
