PHONE INTERVIEW- Peter Lanza

Peter stated that Nancy never worked at the school at any point in her life. Peter stated that Nancy may have helped out with field trips and other school functions only while Adam was a student there. Peter stated that Nancy did not have any affiliation with the school after Adam graduated. Peter further stated that Nancy would not have had the time to volunteer at the Sandy Hook Elementary School or elsewhere because she would always be assisting Adam.
