ACTION TAKEN: On 01/17/13 at approximately 1000 hours, I conducted a telephone interview with 04 04 Professor at Western Connecticut State University. I had called 04 office several times regarding information that this office received that he (04 was an instructor of Adam Lanza's at Western Connecticut State University. The information that this office received 04 04 was that Adam Lanza had attended a course in the Fall of 2008 and a course in the Summer of 2008. stated that when he saw the news reports from the Newtown shooting, he saw the image of Lanza on TV and recalled the face because Lanza was so very young when he was in his class. 04 stated that he remembers him as being quiet and that was it. stated that everything else he had to look up in his computer records. 04 04 stated that Lanza took two classes with him in summer 2008, a 04 04 class and a class. He stated that he had good grades. 04 stated that he also took a 04 04 class in the fall and did poorly on the first test and never came back. 04 stated that he had never met Lanza's mother nor had he any personal one on one contact with Lanza and does not remember much about him.
