Interview Report: Kathleen Koenig, APRN

Koenig, Kathleen A

On Wednesday December 19, 2012, at approximately 1100 hours, FBI S/A Tim Kobelia and I met with Yale Child Studies Center Advanced Practice Registered Nurse, Kathleen Koenig, who had worked at Yale for the past sixteen years. Yale Associate General Counsel, Matthew Varughese, was present for the interview.

Between the hours of 1115 and 1310 hours, I conducted a verbal interview, which culminated in a written statement, which was notarized by myself and witnessed by S/A Kobelia. Koenig's two-page written statement is attached to this report.

Koenig's statement included the fact that she had conducted four (4) face-to-face meetings with Adam Lanza between 10/24/2006 and 02/07/2007. Koenig also conducted various email and telephone contacts with Adam Lanza's mother, Nancy Lanza, during this period. When Koenig first met with Adam Lanza, he had already been examined by Dr. Robert King, M.D. (See separate Interview Report regarding Dr. King.) Subsequent to 10/24/2006, Koenig learned that Adam Lanza was continuing to be seen by Dr. Paul Fox, M.D., who was characterized by Koenig as Adam Lanza's "Primary Psychiatrist."

Koenig had received information from Dr. King which outlined his belief that Adam Lanza suffered from a profound Autism Spectrum Disorder, with a secondary diagnosis of Obsessive Compulsive Disorder (OCD).

Koenig expressed her believe that Adam Lanza's primary diagnosis was OCD, with a secondary diagnosis of Autism Spectrum Disorder.

Koenig stated Adam Lanza's OCD severely limited his ability to lead a normal, well-adjusted life. She described him as "Emotionally Paralyzed." Adam Lanza participated in multiple daily rituals – behaviors which he felt compelled to complete – which included the following:

- Sensitivity to light
- -- Inability to touch doorknobs
- -- Repeated hand-washing/showering
- Obsessive clothes changing
- * Adam Lanza routinely wore the same style clothing (blue polo shirt, khaki pants, 20 sock changes per day) to the degree that Nancy Lanza needed to complete three loads of laundry per day.
- -- Distinct avoidance of social interaction Koenig reported that when Adam Lanza would hear people on the other side of a door, he would wait for them to leave before opening the door.

After speaking with Adam Lanza, Koenig provided Nancy Lanza with two recommendations:

- -- Koenig prescribed medication: Celexa anti-depressant/anti-anxiety
- -- Koenig recommended Adam Lanza participate in follow-up visits

Koenig described Nancy Lanza's response to her recommendations as "non-compliant."

Specifically, immediately after prescribing a small dose of Celexa to Adam Lanza, Koenig received a phone call from Nancy Lanza which reported her son was "unable to raise his arm." Nancy Lanza was reporting her son was attributing this symptom to the medication. Nancy Lanza stated due to her son's symptoms, he would be discontinuing use of the medication. Koenig attempted to convince Nancy Lanza that the medication was not causing any purported symptoms which Adam Lanza might be experiencing. However, Nancy Lanza was not receptive to Koenig's reasoning.

Koenig stipulated that during their interactions, Adam Lanza had asked Koenig specific questions about schizophrenia and OCD. Koenig got the



sense that Adam Lanza was seeking information, but was unwilling to share if he was experiencing any of the symptoms of the disorders. She discussed clinical components of the disorders with Adam Lanza. Koenig also discussed the components of Psychotic Depression with Adam Lanza.

Nancy Lanza also missed at least one scheduled appointment (unknown date), and failed to schedule subsequent appointments for Adam Lanza.

Koenig did contact Dr. Paul Fox and agreed that his behavioral-based therapy would remain the primary course of treatment for Adam Lanza. Koenig planned on continuing to assist Fox in his treatment. However, she stated that Adam Lanza never returned for follow-up visits.

On 12/19/2012 at 1120 hours, Koenig provided me with a sealed manila envelope containing her notes and other paperwork pertaining to Adam Lanza. I transported the paperwork to the Newtown Command Post, where I gave the envelope to Detective Rachel Van Ness at approximately 1420 hours.
