Upon reaching out to **04** she informed me that she did remember Adam Lanza and would be willing to talk with me.

04 stated that Adam Lanza was a student in her 04 class in the spring of 2009. Lanza stood out to her because he was so much younger than the other students but looked like a scrawny 12 year old with oversized clothing. Lanza was a quiet student and would look away when she would look in his direction. 04 stated that on the few occasions when students were asked to talk with a classmate, Lanza tended not to interact.

04 stated that for the final paper, Lanza had to write about the history of the creation of the Federal Reserve and instead he went on a tangent about the Federal Reserve and the US government going off the gold standard. 04 stated that people that usually argue these ideas are typically libertarians to the extreme and embrace an array of conspiracy theories. 04 stated that typically college students are not familiar with these ideas and do not have such strong opinions. In our telephone interview 04 provided to me the example of Timothy McVeigh as being someone who participates in this type of thinking. Refer to attached statement.
