Action Taken: On 2/2/13, this Detective responded to the Misty Vale Deli and Grocery, 51 Berkshire Road, Sandy Hook, to investigate information received from 01 02 03 12 pertaining to the ongoing investigation.

Upon arrival, this Detective met with manager Angel Salazar, D.O.B. 03 and relayed that it had been stated that the shooter responsible for the death of 26 people at the Sandy Hook Elementary School on 12/14/12, had been seen at the Misty Vale in the days before or on the day of the shooting. Salazar stated, in part, that both he and many of the other employees have been asked countless times by customers if they knew or had seen the shooter in the deli, and that the answer was no. Salazar further stated that he and his employees had seen photos of Lanza on television, but did not know if those were even recent pictures or if Lanza looked in person like he did in the photos. A sworn written statement was obtained from Salazar (see attached).

The status of the case remains actively under investigation.
