04 related that he has resided in 03 for approximately twelve years and that he is the owner of 04. That in 2004, he met Nancy Lanza in town and they dated on and off for approximately two years. 04 related that during that time, he knew that Nancy had two sons, but he never met them. 04 related that Nancy always spoke about her sons and specifically how intelligent Adam was, but that he was also very distant when it came to his "feelings" and that he needed everything in his life a certain way. 04 further related that Nancy once told him that Adam hacked into a Government web site and agents from the Federal Bureau of Investigation came to her residence.

Lastly, 04 stated that he remembered Nancy always talking about another individual that she dated who she identified as 04 from 04.
