PURPOSE: Find background information on Nancy and Adam Lanza

BACKGROUND: Christian Hansen has been a NRA instructor since 1991 or 1992. He was employed at Fairfield County Indoor Range/ Arms And Munitions in Monroe, CT from 1986 through November of 2010, when it burned down. Mr Hansen taught the NRA safety courses to both Nancy and Adam Lanza.

ACTION TAKEN: On Tuesday, December 17th, at approximately 1130 Hrs, Detective Combes and I met with Christian Hansen at the Detective Bureau, Newtown Police Department to conduct his interview. Mr Hansen heard about the tragedy and came to the Newtown Police Department in an effort to offer some insights into Nancy and Adam Lanza. After conducting the interview, Mr Hansen signed his sworn statement.

Christian Hansen's statement is the following: "I am an NRA Instructor and have been since 1991 or 1992. I have taught basic firearms certification courses. I was employed at Fairfield County Indoor Range/ Arms And Munitions in Monroe, CT from 1986 through November of 2010, when it burned down.

When I saw the media picture of Adam Lanza, I recognized him. I believe it was about 4 years ago when he and his mother took a basic safety class from me. I remember the mother to be a nice person and Adam to be extremely quiet and polite. To the best of my recollection, the mother took the basic pistol certification class and Adam with his mother took the basic NRA rifle safety course. After they completed the safety course, they came back two or three times within a year of taking the class and rented rim fire pistols and rifles. Both the mother and son were actively shooting when they came to the range. I was working part-time at that time, they could have been there more times. There was a possibility that they brought their own ammunition. I don't recall any one else with them. This was about four years ago, I have not seen them since then. The range records were destroyed, when the building burned down in 2010 and we had no video files.

When I was first employed, at the Fairfield County Range in 1986, Dave Bachman owned the range. Dave sold the store in about 2000 to Pat Loturco, a retired Bridgeport Police Office, who retired to Utah. Pat sold the range to Alan Warmflash in about 2004. Alan owned the range and sold it to Brian Griffin or Griffith in April or May of 2010. Brian owned the range until it burned down in November of 2010.

At the time Adam Lanza and his mother took the basic safety certification courses, and afterward when Adam and his mother returned to shoot a few times, Alan Warmflash was the owner."
