

Clifford Kichar. Kichar was identified during this investigation as being employed by Connor Landscaping and working at Nancy Lanza's residence.

Kichar related that he was introduced to Nancy Lanza by a mutual friend approximately ten to fifteen years ago. That after a period of time, Nancy needed a lawn care service and contracted the company that he was employed by. That during the time he worked at Nancy's residence, he had many interactions with Nancy. Kichar stated that Nancy would instruct him not to utilize loud equipment when Adam was home because it would "freak" him out. Kichar recalls one incident in which Nancy reprimanded him for ringing the door bell because it upset Adam.

Kichar related that he never had any contact with Adam other than observing him coming and going from the residence. Kichar stated that on the occasions he did observe Adam; his appearance was "Nerdy."

Kichar further related that Nancy knew that he shot competitively and asked several times if she could attend the competitions with him. Nancy informed him that she owned her own guns and when she was married, shot trap/skeet with her husband. Kichar stated that he never observed any of her firearms, but was under the impression that she owned a "high end" shot gun.

Lastly, Kichar stated that Nancy dated his friend, 04 on and off for a few years.
