Robert Connor. Connor was identified during this investigation as being hired by Nancy Lanza to maintain the exterior portion of her residence located at 36 Yogananda Street, Sandy Hook, Connecticut.

Connor related that he is the owner of Connor Landscaping and that sometime in 2007 or 2008; Nancy Lanza hired his company to maintain the property at her residence. Connor related that when he initially met Nancy, she instructed him to never ring the doorbell at her residence because her son had issues with loud noises and they caused him to become angry. Moreover, Nancy informed Connor that when his employees are working on her property, they would have to make arrangements with her before they utilized power equipment, such as leaf blowers because of Adam's condition.

Connor related that he did not work at Nancy's residence much, but when he was there, he never entered the inside of her residence. Connor stated that Nancy was a very private person and whenever they needed to discuss something, she would have him meet her in the yard or at the bottom of her driveway.

Connor further related that when work needed to be completed at Nancy's residence, he typically sent a two-man crew, which was led by Clifford Kichar.

Lastly, Connor related that he never met Adam Lanza.
