That on December 19, 2012 at approximately 1700 hours, Detective Richard Covello and I spoke with and obtained a written statement from **104** was identified during this investigation as being a past boyfriend of Nancy Lanza.

of related that he met Nancy Lanza three or four years ago at the Redding Road House. They dated on and off for approximately one year and during that time period, their relationship was romantic in nature. **O4** stated that they met often at local restaurants and she visited his residence on a few occasions. **O4** related that he has never been to her residence or met her sons.

**04** further stated that during their relationship, Nancy spoke of her hobbies and interests, which included gardening, firearms and her growing up in New Hampshire. **04** stated that Nancy also spoke of Adam's interest and personality, but he never got the impression that Adam had a violent nature. Moreover, **04** stated that he got the opposite impression, that Adam was a peaceful and quiet young man who was a strict vegetarian and who was interested in string instruments and considering enlisting in the Armed Forces.

Lastly, 04 related that he never resided in England or traveled abroad.
