LOCATION: This interview was conducted in the interview room at Troop A, located at 90 Lakeside Rd. in Southbury, CT.

ACTION TAKEN:

On 03/06/13 at approximately 0815, 04 arrived at Troop A to provide a statement regarding her actions on 12/14/12 at Sandy Hook Elementary School. The following is a summary of the written statement provided by 04

04 stated that she arrived at Sandy Hook School at around 9:40am on 12/14/12. She stated that a police car pulled into the parking lot behind her. She stated that there were police cars along Dickinson Dr. and in the parking lot. She stated that she saw 04 in the parking lot and 04 told her that there was a shooter in the school. She stated that she heard a man say that he came to the school to make gingerbread houses

and he heard pop, pop, pop. She stated that he heard him ask where is [01 02 03 12], was. She stated that she assumed it was [01 02 03]. She stated that she called [04] where her daughter attends classes and they told her that everything was fine. She stated that [04] called her back a few minutes later and told her to come pick up her daughter because she was sick. She stated that she left Sandy Hook School and began heading to [04] to get her daughter. She stated that she was about half way to [04] when they called her again and told her that the school was in lock down. She stated that she sat in the parking lot at [04] until the lock down was lifted. (See attached statement)
