Peter Lanza - Clarifying Questions

Action Taken: On Friday, March 29, 2013 Peter Lanza came in to Troop G in Bridgeport, in order to retrieve mail addressed to the Lanza family. Sgt. Pattberg asked me to ascertain whether Peter had any knowledge of who had primary use of the Honda Civic driven to Sandy Hook Elementary School. In addition, he asked me to find out who the Garmin Nuvi GPS unit belonged to.

Peter explained that he purchased the Honda Civic in 2010 for Adam and had the vehicle registered in Nancy Lanza's name. Peter stated that he assumed Adam was the only person who primarily used the vehicle, but he could not say for sure due to his limited interaction with Adam over the past two years. When asked about the Garmin Nuvi GPS unit Peter stated that he had purchased the unit for himself and used it until approximately June 2010. Peter stated that it was around that time that he gave the device to his son Adam to use. Again Peter stated that he assumed Adam was the only one who used the GPS device, but he could not say with any certainty due to his limited interaction with Adam.

On December 26, 2012 the FBI met with [REDACTED] 04 who is currently incarcerated in the State of Mississippi, and claimed to have knowledge regarding the shooting at Sandy Hook Elementary School. In his statement he describes meeting a women by the name of [REDACTED] 04 while at a rehabilitation facility in Oklahoma back in 2008. He describes [REDACTED] 04 as a [REDACTED] 04 to Adam Lanza. [REDACTED] 04 stated that [REDACTED] 04 told him of the plan that Adam Lanza had to kill his mother and the students of Sandy Hook Elementary while at the facility together.

I spoke to Peter Lanza on this matter and asked if he was related to [REDACTED] 04 or if he had ever heard of her before. Peter stated that [REDACTED] 04 was not a member of his family, and he has never heard that name mentioned prior to our discussion.
