04 of 03. 04 had contacted the State Police and reported seeing a small dark colored car on the morning of the shooting at the Sandy Hook Elementary School.

I contacted 04 via telephone and asked if we could come speak to him. 04 agreed and Detective Dwyer and I responded to 04 home. We arrived shortly after 1300 hours and were invited in by 04 to discuss what he saw that morning.

In a written statement, 04 stated that on Friday, December 14, 2012, he was meeting a friend of his at the Misty Vale Deli on Route 34 for a 9:15 am meeting. 04 stated that he and his friend arrived at about 9:10 am, ordered breakfast and ate their food outside the deli on a picnic table. 04 stated that after they finished eating, he and his friend started to walk towards the wooded lot across the street from the deli. 04 stated that as they started to cross the street, he looked to the east and saw that the traffic seemed to be moving at a slower than usual rate of speed and was all bunched up. 04 stated that he was about 50-60 yards from the lead car, a dark colored sedan when he crossed the street. 04 said that he did not get a good look at the driver, but thinks that this may have been the vehicle driven by Adam Lanza prior to the shooting at the elementary school. 04 concluded by saying that he saw this car at about 9:20 to 9:25 am and that the vehicle was heading west on Route 34 towards the school.
