On Friday, December 14, 2012, this investigator and Fairfield Police Detective Peter Koval were assigned to respond to [REDACTED] 03 and assist with the neighborhood canvass of the homes near the Lanza residence.

At approximately 1810 hours, we met with [REDACTED] 04, 03 stated that he moved to the neighborhood [REDACTED] 04 stated that neither he or [REDACTED] 04 have had any interaction with the Lanza family and has no idea who lives in the house.

The only unusual activity that was reported was noticed by [REDACTED] 04 About two weeks prior to the shooting, she heard some unusual gunshot like sounds in the evening hours. She was unsure if they came from the Lanza residence and was unable to determine where the sounds came from. No one in the [REDACTED] 04 family reported seeing any bizarre or unusual activity from the Lanza residence.
