Action Taken:

That on December 15, 2012 at approximately 1620 hours, Detective Richard Covello and I spoke with and obtained a written statement from **104 mercent** was identified during this investigation as **104 04 mercen** of Nancy and Adam Lanza.

04 related that he has resided in **Constant 103 second and** since that time, Nancy Lanza had visited his residence on several occasions. **104** related that the last time Nancy had visited, they debated about firearms. **104** related that Nancy grew up hunting and was very proud of her firearm collection. **104** related that he never met Adam, however he knew that Nancy had taken him out of school because he was sensitive to sound and light.

Lastly, 04 related that on December 14, 2012, he was working 04 during the morning and between 8 and 9am, he heard two or three gunshots. 04 related that he believed the gunshots came from hunters, however he felt this time that they were unusually close.
