Action Taken:

That on December 15, 2012 at approximately 1620 hours, Detective Richard Covello and I spoke with and obtained a written statement from [04] was identified during this investigation as [04] of Nancy and Adam Lanza.

[04] related that she has resided in [03] and that she [03] the Lanzas. [04] stated that when they first moved into town, [04] was in [04] grade with Adam Lanza. [04] recalls one of her [04] first assignments in which the class was asked to construct a "hand poem" with something they liked about themselves on each finger. [04] states that [04] came home upset and told her that the boy [04] did not like himself and that he wrote, "ugly and loser" on each of his fingers.

[04] stated that Adam was always troubled, but brilliant. [04] recalls when Adam was in ninth grade; Nancy Lanza told her a story regarding how either the Central Intelligence Agency or Federal Bureau of Investigation came to her residence because Adam "hacked" through two levels of security on one of their computer networks. Nancy allegedly told [04] that when the agents came to her residence, she had to convince them that he was a "computer whiz" and just a kid that was challenging himself.

[04] stated that Nancy Lanza was a gun enthusiast who grew up in either Vermont or New Hampshire. During some of their conversations, Nancy told [04] that she grew up hunting and she loved the power of the gun.

Lastly, [04] stated that [04] had mentioned to her that she could picture Adam doing what he had done at Sandy Hook Elementary School with a smile on his face.
