Location:

The interview took place in an office area at the North Castle Police Department, 15 Bedford Road, Armonk, New York. Present during the interview were detective Richard Covello #376 and I. The interview began on December 20, 2012 at approximately 1850 hours and ended on December 20, 2012 at approximately 2045 hours.

Action Taken:

That on December 20, 2012 at approximately 1850 hours, I spoke with and obtained a written statement from [REDACTED] 04 was identified during this investigation as a friend of Adam Lanza.

[REDACTED] 04 stated that he has known Adam Lanza since 2011 and they met through a mutual acquaintance at a movie theater located in Danbury, Connecticut. [REDACTED] 04 stated during that time, they met at the movie theater approximately three times a month to play arcade games. [REDACTED] 04 stated that the only game he played with Adam was Dance Dance Revolution and that they never played any "first shooter" type games.

[REDACTED] 04 stated that in between playing arcade games, they would have discussions on current topics or a conversation involving what was happening in their lives. [REDACTED] 04 stated that they talked about family, specifically about Adams relationship with his mother and how it was strained. According to [REDACTED] 04 Adam had told him that he was unable to communicate with his mother because her behavior was not rational and she was unwilling to talk about certain topics that he felt were important. [REDACTED] 04 stated that other topics of discussion included the Chimp society; their relationship with humans and how they treat one another. Another topic of discussion was pedophilia. [REDACTED] 04 stated that Adam once told him that he had expressed his opinion on an internet blog that pedophilia was a disease that needed to be treated and not looked at as evil.

[REDACTED] 04 stated that both he and Adam liked to watch movies together. They both enjoyed 1980s / 1990s psych-thriller type films such as "Henry" (portrait of a serial killer), "The Thing," and "Invasion of the Body Snatchers."

[REDACTED] 04 stated that he and Adam also used computers to play games and communicate. [REDACTED] 04 stated that Adam frequently formatted his computer hard drive. [REDACTED] 04 stated that one time, during conversation, he brought up the topic of formatting computer hard drives as a way of keeping "off grid," but Adam never commented. [REDACTED] 04 stated that he believes that Adam was formatting his computer hard drive to stay "off grid" because "keeping off grid" was something that their group or people like them do to hide what they have done or where they have been on their computer.

Lastly, [REDACTED] 04 stated that he stopped talking with Adam sometime in June of 2012. [REDACTED] 04 stated they became involved in a disagreement in
