INTERVIEW REPORT: 04 [REDACTED], PROFESSOR AND DIRECTOR OF GERMAN STUDIES, WESTERN CONNECTICUT STATE UNIVERSITY

ACTION TAKEN: On 07/26/13 at 1142 hours, I conducted a telephone interview with 04 [REDACTED], a professor of German studies at Western Connecticut State University. I had called 04 [REDACTED] regarding information that this unit had that Adam Lanza had taken a German class taught by her 04 [REDACTED]. 04 [REDACTED] stated that when the shooting event had occurred in December and it was all over the news, she had no recollection of Lanza. 04 [REDACTED] stated that prior to me getting in contact with her, she had been approached by the press and informed them of the same. 04 [REDACTED] stated that when she went and looked Lanza up in her records, she realized that he was a student of hers. She stated that Lanza took introduction to German, which is a beginners course. 04 [REDACTED] stated that as a professor, she finds that most students who take German are high achievers and highly motivated students. Many students will impress her and she will remember them. 04 [REDACTED] stated that when she looked at Lanza's records, she saw that his grades were no good and it was no wonder that he did not impress her. 04 [REDACTED] stated that basically Lanza came and went in her class with no real interaction, as she would have remembered if there was. 04 [REDACTED] also stated that she did not have a final grade for Lanza which meant that Lanza had dropped out and never took the final. 04 [REDACTED] stated that basically there was little about Lanza to recall.

CASE STATUS: This case will remain active pending further investigation.
