WITNESS INTERVIEW REPORT: 04

On August 7th, 2013, from approximately 1800 hours to 1840 hours, Det. Jewiss and I met with 04 within the Troop A – Southbury barracks cafeteria. We obtained a verbal and sworn written statement from 04 who stated: "On Wednesday, August 7th, 2013, my father and I voluntarily met with Detectives Jewiss and Mudry within the Connecticut State Police Southbury barracks.

At this time using several maps I was asked to identify which classrooms I was in with Adam Lanza during my education at Sandy Hook School.

The Detectives provided me with a poster sized map of the school for easier viewing and a letter sized map. Both maps contained the same details. I checked off the following rooms that I remembered attending class with Adam Lanza on the letter sized map (Refer to attached map) : 04

From my recollection, I believe the "portables" or Modular classrooms were built while I was attending the third grade.

Also, I believe the school was structured in a square by age. Meaning, entering the school walking west, later changed to east, would be the following order: First, Kindergarten, Third, Fourth, Fifth and Second." (See attached statement and map for details.)
