**WITNESS INTERVIEW REPORT: COREY DAVIDSON**

On August 14th, 2013, from approximately 1600 hours to 1618 hours, I met with witness, Corey Davidson, within Loews Theatres located at 61 Eagle Rd. Danbury, CT to obtain a witness statement. Within the Manager's office, Davidson stated verbally and later in a sworn written statement that for the past four years he has been working at the AMC (Loews Theatres.) He has seen the shooter almost every weekend up until a month prior to December 14th, 2012. Davidson describes the shooter as being a "regular" who would come to the theatre alone, not to watch movies but to specifically play Dance Dance Revolution (which he seemed to have mastered at an expert level.) The shooter would rarely interact with anyone aside from the few times he would go the guest service desk to ask for tokens used for the game. He would usually arrive at the theatre around 6pm and leave around 10 or 11pm. As to he played the game he would never show any emotion. No matter what the temperature was outside the shooter would always wear the same clothing, a sweater and pants. The shooter frequented the theatre so much that he was deemed "DDR Boy." He would play the game so much that he would sweat profusely, but he still persisted to play. The last time that Davidson saw the shooter was sometime in November about a month before the shooting. Davidson initially learned that "DDR Boy" was the shooter after a Film Crew Member recognized him from a photograph on the internet (See attached copy of statement for details.)

During this interview I showed Davidson two photographs of which he immediately identified the shooter as "DDR Boy" but not Nancy Lanza (See attached photographs.)
