ACTION TAKEN: During this investigation, the unit received information that Nancy Lanza had a scheduled appointment on 12-14-12. The information came to us through the interview of [REDACTED] 04, a friend of Nancy's, who stated that Nancy could not give him a ride to his hair appointment on 12-14-12, because she stated that she had an appointment in Westport and would not be back in Newtown until 5:00 PM.

In March, Det Lamoureux, from Eastern District Major Crime, who during the investigation of her death, seized boxes of personal papers from the home of Nancy Lanza at 36 Yogananda Street, Newtown; sent me a photo of Lanza's appointment book (SEE ATTACHED PHOTO). The photo showed an entry for December 14, 2012 that indicated that Nancy Lanza had an appointment with someone at @ 2:00 PM. The name in the appointment book was hard to read and was either "04" or "04". This name appeared quite frequently in the appointment book on a weekly or bi-weekly basis.

On 03/18/13 at approximately 1500 hours, I called [REDACTED] 04, reported to be Nancy Lanza's boyfriend, to inquire why Nancy Lanza would frequent the Westport area and if he knew who "04" or "04" was. [REDACTED] 04 stated that Lanza would primarily go to Westport to shop for clothing and would frequent the high end health food stores for groceries. [REDACTED] 04 stated that her doctor's office was in Stamford. [REDACTED] 04 informed me that the 2:00 PM appointment was with "04". [REDACTED] 04 told me that [REDACTED] 04 was a female and a high end seamstress/dressmaker. [REDACTED] 04 stated that [REDACTED] 04 was also a friend of Nancy's and that Nancy would have dinner with [REDACTED] 04 once a week.

[REDACTED] 04 also stated that if something was not in Lanza's day book then it did not happen. He informed me that it was basically a "journal" of her life

and that he often joked about it with her.

I then reviewed the interviews that were conducted shortly after the shooting incident and saw that the US Marshalls interviewed a [04, 03], a dressmaker, on 12-19-12, regarding her relationship with Nancy Lanza. On 03-18-13, at approximately 1600 hours, I called [04] regarding her appointment with Nancy on 12-14-12. I found that [04] was very reluctant to speak with me. [04] informed me that she had known Nancy Lanza since 2003 and she stressed that they only had a business connection. [04] stated that Nancy had asked [04] to give her a complete style makeover. [04] stated that they were polite to each other but were not friends. [04] was very reluctant to tell me of the appointment and it was only when I told her of her name in Nancy's day book did she admit to me that Nancy had an appointment with her at @ 2:00 PM on Friday 12-14-12 for a dress fitting. [04] stated that she last spoke to Nancy a few days before the shooting incident regarding the appointment. I then informed [04] that I would like to meet with her to obtain a written statement regarding the appointment and would contact her in a few days to set it up. [04] questioned why I needed this and again seemed very reluctant to cooperate.

Since the telephone interview on 03-18-13, Det Downs and I have made several attempts to personally appear at [04] home and place of business on [03] to obtain a statement from her and to ask her more questions. During those attempts, no one has been present at the home and during some of those attempts, we have seen evidence of someone present in the home but refusing to answer the doors. I have made several telephone calls and have left my business card in her mailbox in an attempt to have [04] contact me. As a result of her reluctance to speak with detectives, I was not able to obtain a sworn statement from [04]

CASE STATUS: This case will remain active pending further investigation.
