INTERVIEW REPORT: 04

Throughout the investigation, Detectives learned that the shooter and 04 co-authored a book called, "The Big Book of Granny." In an attempt to locate 04 I left a voice message on his home phone number of 03 for 04 with my return phone number.

On Thursday, August 29th, 2013, I was contacted by 04 stated verbally that 04 is currently residing 03, 04. She stated that she spoke with 04 about the shooter and that he doesn't remember too much about him. 04 stated that Detectives would not be able to obtain a great deal of information from 04 due to 03, 04, so she provided me with what she knew. 04 grew up 04 and the shooter attended 04 together at Sandy Hook School from 04. This information was confirmed through copies of the Sandy Hook School Directory. Furthermore, the School Directory shows that 04 started attending Sandy Hook School in 04 and only attended 04 grade with the shooter during 04 (See attached.) Throughout the school year, as class projects were handed out, 04 and the shooter would work together on them because of their close proximity at home. 04 was unsure of them co-authoring "The Big Book of Granny", but it sounded reasonable that they would do so for school projects. 04 and the shooter would ride bikes together in the neighborhood and do "boy stuff." The shooter has been over the 04 residence on a few occasions and 04 described him as having been being normal and polite. 04 has been over the shooter's residence and there were never any worries or incidents that brought attention to 04

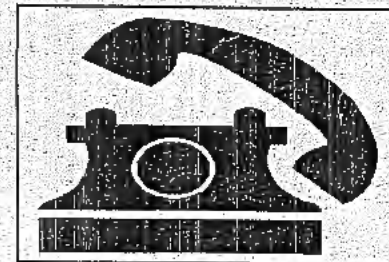

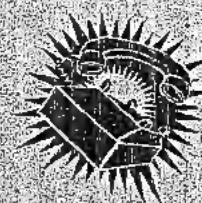
