**WITNESS INTERVIEW REPORT: MARVIN LAFONTAINE**

On September 4th, 2013, from approximately 1400 hours to 1457 hours, Det. Downs and I conducted a phone interview with Marvin Lafontaine. During the interview, Lafontaine stated verbally that his family and the Lanza family became friendly through the "Scouts" where all their boys attended. Lafontaine held weekly Scout meetings at his residence and Nancy would bring her boys to attend. Nancy's husband, Peter, was a hard worker so he never really saw him at the meetings, but both families often went out together.

Before the Lanza family moved from New Hampshire in 1998 to Connecticut, Lafontaine stayed in touch with Nancy frequently. They would talk on the phone at least once a week, e-mail each other once a day and meet once a month in Boston for dinner.

In 2003, Lafontaine left his current job and lost contact with Nancy, meaning, she had his work number and would call him there.

Lafontaine stated that he used to copy and paste Nancy's e-mails onto a word document because he has had trouble in the past with Yahoo losing them. Unfortunately, Yahoo lost a large portion of the e-mails that he had not pasted onto a word document because of inactivity on his account. Lafontaine further stated that those lost e-mails contained information that the shooter was being bullied in school verbally and physically while he attended middle school and high school. Lafontaine will be attempting to contact Yahoo to retrieve those e-mails. Lafontaine remembers on two occasions that Nancy told him that the shooter came home from school with bruises and Nancy was very upset by this. It got to a point that Nancy started accompanying the shooter to school and stayed in his classrooms because the teachers didn't do anything. Lafontaine stated the

correspondence that he did save he will be e-mailing to me at my work address. He further stated that he will be sending two sets of documents, the first from 1998 and the second from 2008-2009. On September 13th, 2013, I received two e-mails from Lafontaine containing the attachments of e-mail correspondence (See attached correspondence.)

The last time that Lafontaine had heard from Nancy was in February 2012. She had reached out to him, via his Facebook account, just simply saying hello. At the time, he didn't know how to use Facebook so he didn't see the post until a couple of weeks ago.

Nancy never said anything negative about her kids; she always spoke of them positively. Lafontaine specifically remembers Nancy telling him that the shooter is as "neurotic" as she is.

Lafontaine stated he never had an intimate relationship with Nancy, however he wanted it. He felt that she wanted intimacy too, but something told him not to act on it.

Lafontaine remembers telling Nancy about a traumatic event that he had. When he was younger he got into an accident. His best friend was killed and he lost his leg. Nancy then stated that she too suffered a traumatic event but didn't want to explain it. Since Lafontaine has a close relationship with [REDACTED] 03, 12 [REDACTED]

As a hobby, Lafontaine and Nancy would take their boys shooting behind his house where he had a makeshift gun range. At the time, the shooter was 5 years old. Here, he and Nancy taught the shooter to fire a .22 and a high powered air rifle. Lafontaine stated that the boys were really bad shots.

Lafontaine described the shooter as being quieter than other boys, but brilliant with an extremely high IQ. He specifically remembers the shooter walking around making a "chit chat" noise that he personally felt was cute.

Lafontaine went on to state that the media in the past has severely misquoted him.

Lafontaine provided that he has heard about the shooter taping his clips together and reloading during the Sandy Hook School shooting. Lafontaine went on to state that if you are planning to shoot multiple rounds then taping the clips together and reloading is the right way to do it.
