WITNESS INTERVIEW REPORT: [REDACTED] 04

On September 13th, 2013, from approximately 0735 hours to 0755 hours, Det. Downs and I met with witness, [REDACTED] 04, within Reed Intermediate School located at 3 Trades Ln. Newtown, CT. The interview was conducted within the conference room. [REDACTED] 04 stated verbally and later in a sworn written statement that he has been a teacher for the past [REDACTED] 04 years. He has been teaching at Reed for the past [REDACTED] 04 years and before that Sandy Hook School.

[REDACTED] 04 stated that the shooter was his student in the [REDACTED] 04 remembers the shooter being quiet, reluctant, very bright and had good ideas regarding creative writing. The shooter wouldn't necessarily engage in conversation with people but he wouldn't ignore them either.

[REDACTED] 04 only remembers seeing the shooters' mother in the classroom during the reading of their persuasive essay. [REDACTED] 04 doesn't remember any incidents of teasing or bullying of the shooter.

We asked [REDACTED] 04 if he remembered a student by the name of [REDACTED] 04, 01 02, which he did remember. He stated that [REDACTED] 04, 01 02 was in the gifted and talented program. [REDACTED] 04, 01 02 always seemed to take the longer route to [REDACTED] 04 classroom but always made it on time. [REDACTED] 04 does not remember [REDACTED] 04, 01 02 or the shooter associating with one another.

We asked [REDACTED] 04 if he remembers a book that was co-authored by the shooter and [REDACTED] 04, 01 02 "The Big Book of Granny", which he did not remember (See attached copy of statement for details.)
