Within the office conference room, 04 stated verbally and in a sworn written statement that she was the shooter's 404 teacher for homeroom, language arts, reading and social studies. 404 stated that the shooter was an average student, earning As and Bs and homework was never an issue. The shooter was reserved in the classroom, never made trouble or distracted others. During class, the shooter was focused and when called upon would know the answer. There was never any behavioral or class work that were of any concern to the shooter or others' well-being. The shooter did have friends and others were friendly to him. 04 stated that there were never any reports of bullying or teasing. In 04 opinion, the shooter was a normal child with no oddities (See attached copy of statement for details.)
